Parent/Coach Code of Conduct

We the Bronson Parks & Recreation Department have implemented the following Code of Conduct for the import message it hold about the proper role of parents in supporting their child in sports activity. Parents, Guardian and Coaches must read, understand, sign and adhere to these policies prior to their children participating in the league.

Any adult quality of improper conduct at any game, practice or function will be asked to leave the property and be suspended form the following game. Repeated violations may cause a multiple game suspension, or the season forfeiture of the privilege of attending all games.

Bronson Parks & Recreation Mission Statement

The Bronson Parks & Recreation Department will make every effort to provide the best coaches, equipment and facilities that are possible to ensure the best for our children. We will promote the essential elements of character-building and ethics in sports that are embodied in the concept of sportsmanship with these six core principles: Trustworthiness, Respect, Responsibility, Fairness, Caring and Good Citizenship. We strive to instill these traits in our children to give them every opportunity that they deserve in life.

I therefore agree:

I will not force my child to participate in any sport, and I will remember that children participate to have fun and that the game is for youth, not adults

I will inform the coach of any physical disability or ailment that may affect the safety of my child or others

I will learn the rules of the game and polices of the league

I and my guests will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy for other, and by demonstrating positive support for all players, coaches, officials, and spectators at every game, practice or event.

I and my guest will not engage in any un-sportsman like conduct with any official, player, coach, or parent such as: booing, taunting, refusing to shake hands or using foul language.

I will not encourage any behaviors or practices that would endanger the health and wellbeing of the athletes.

I will teach my child to play by the rules and to resolve conflicts without resorting to violence or hostility.

I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.

I will teach my child that doing ones best is more important than winning, so that my child will never feel defeated by the outcome of the game or his/her performance.

I will praise my child for competing fairly ad trying hard, and make my child feel like a winner every time.

I will never ridicule or yell at my child or others participants for a making a mistake or losing a competition.

I will emphasize skill development and practices and how they benefit my child over winning and I will also de-emphasize games and competition in the lower age groups.

I will promote the emotional and physical wellbeing of the athletes ahead of any personal desire I may have for my child to win.

I will respect all officials and their authority during games and will never question, discuss, or confront coaches at the fame fields. I will take time to speak with coaches at an agreed upon time and place.

I will demand a friendly sports environment for my child that is free from drugs, tobacco and alcohol and I will refrain from their use at all sports and social events where children are present.

I will refrain from coaching my child or other players during games and practices, unless I am the official coaches of the team.

I will refrain from promoting any negative issues within or about the youth league, its officers, coaches or parents.

I will address any issues, questions or disagreement with the appropriate people within the Parks Department and will not resort to "social networking" to vent any frustration, complaints or issues I may have as this not the proper avenue to resolve conflicts.

Parent/Guardian's Consent for Athletic Participation and Waiver of Liability

In consideration of my child's participation in one or more athletic programs offered by the Town of Bronson Parks & Recreation Department, I hereby **WAIVE, RELEASE AND RELINQUISH** any right to bring action against the Town of Bronson or any employee, agent or contractor associate with or operating under the aegis of the Town of Bronson for any claim for personal injury, wrongful death or property damage arising out of my child's participation in an athletic program and attributable to ordinary negligence on the part of any of the parties listed above wherever, whenever, or however the same may occur. I fully understand that all of the parties listed above and their insures, if any, are fully insulate and released from any claim including any claim based on their negligence. I further understand that participation in an athletic program involves unavoidable risks including the risk of serious injury. I am allowing my child to participate in the program with this knowledge and with acceptance of the risks involved.

I certify that my child is in excellent physical health and physically able to the best of my knowledge participate in strenuous and potentially injury- producing physical activities required by sport whether it be football, basketball, baseball, softball, T-ball or soccer. I further certify, consent and agree that my child has permission to be transported to games, practices and other activities where necessary by member of the program. Permission is further granted to my child to receive emergency medical treatment, should it be needed, with notification to me of any incident requiring such treatment as soon as practicably possible. I further agree to allow representatives of the Town of Bronson's Athletic program to use the name and likeness of my child in promotional material without compensation.

I understand that this document is intended to be as broad and inclusive as the law will allow and agree that if any portion of this agreement should be invalid as a matter of law, the remainder will nevertheless continue with full legal force and effect as is so intended.
