RESOLUTION 04-01

**A RESOLUTION AMENDING RESOLUTION 01-05 AND
RESOLUTION 97-1 TO ESTABLISH RATES FOR THE
TOWN OF BRONSON WATER AND SEWER SYSTEMS;
PROVIDING FOR ANNUAL REVIEW OF RATES; PRO-
VIDING FOR CLASSIFICATION OF RATES ON THE BASIS
OF DEMAND, LOCATION, LAND USE AND OTHER
FACTORS AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Chapter 22 of the Town of Bronson Code of Ordinances, as amended by Ordinance 04-05, authorizes the Town Council to establish by resolution a schedule of rates, charges and deposits for the services and facilities of the town; and

WHEREAS, the town has added a sewer system to the Town facilities; and;

WHEREAS, the Town Council has determined that operating cost estimates for the water and sewer system should be reviewed at least annually; and

WHEREAS, the Town Council finds that rates for water and sewer service should be equitable, complementary, based on demand, location, land use and other factors, including the property tax burden of landowners, and shall be in the best interest of the residents of the Town and the integrity of the Town budget and finances;

NOW THEREFORE BE IT RESOLVED that the Town Council in public session hereby adopts the following Exhibit ATTACHED HERETO as though it were fully written and incorporated herein:

**“WATER AND SEWER FEE SCHEDULE

And FURTHER RESOLVES than an Annual Review of water and sewer rates shall be conducted, which shall include consideration of demand on the systems, location of users, land uses and zoning, property tax burden and other factors; and that the cost of operating the systems shall be paid by users to an Enterprise Fund which assures future increases in capacity and service delivery, assures system maintenance and assures that no financial loss will occur.

This Resolution was PASSED AND ADOPTED on July 12, 2004 at a regular session of the Town Council and shall become effective immediately.

**A RESOLUTION OF THE TOWN OF BRONSON, OF LEVY COUNTY
FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM
TAXES FOR FISCAL YEAR 2004-2005; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the Town Council of the Town of Bronson, Florida, on September 23, 2004, adopted Fiscal Year 2004-2005 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Town Council of the Town of Bronson, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Bronson, Florida, Levy County Florida, has been certified by the County Property Appraiser to the Town of Bronson as \$20,477,461.00.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Bronson, Florida, that:

1. The Fiscal year 2004-2005 operating millage rate for Town wide is 3.200 mills, which is greater than the rolled back rate of 3.1191 mills by 2.595%.
2. This resolution shall take effect immediately upon its passage and adoption by the Town Council of the Town of Bronson, Florida.

WHEREAS, the Town Council of Bronson, Florida on September 30, 2004, held a public hearing as required by Florida Statute 200.065; and




NOW THEREFORE BE IT RESOLVED by the Town Council of Bronson, Florida, that:
