WHEREAS, the Town of Bronson, Florida, a Florida Municipal Corporation, is validly chartered and existing under the laws of the State of Florida and is duly authorized to transact business in the State of Florida; and

WHEREAS, the Town Council of the Town of Bronson, Florida, has determined that it is a proper and necessary municipal purpose for the Town to purchase a 2007 Ford F-550 mini-pumper fire truck for use by its fire department; and

WHEREAS, the Town has insufficient cash assets to make the purchase; and

WHEREAS, the Perkins State Bank has agreed to loan to the Town the amount of \$42,500.00 to be secured by a pledge of revenues received by the Town from the Levy County Board of County Commissioners for fire protection services performed by the Town; and

WHEREAS, the Town Council of the Town of Bronson, Florida, hereby finds that, upon consideration of the relatively small amount to be borrowed, after comparison with alternative financing options offered by different lenders, the costs associated with competitively bidding for placement of the loan, and the benefit to the citizens of Bronson derived by dealing with a locally owned financial institution, that it would be in the best interest of the Town to directly negotiate the loan with The Perkins State Bank rather than award the loan at a public sale based on a competitive bidding process;

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRONSON, FLORIDA, THAT:

Franklin Schuler, as Mayor and presiding officer of the Town of Bronson, Florida, acting for and on behalf of the Town is hereby authorized and empowered to:

A. Borrow from THE PERKINS STATE BANK, ("Lender"), the sum of Forty-two Thousand Five Hundred Dollars (\$42,500.00), in addition to any such sums that may be currently borrowed by the Town from Lender; and

B. Execute and deliver to Lender a promissory note in a form identical to that which is attached hereto as Exhibit "A", which promissory note includes a pledge of revenues received by the Town from the Levy County Board of County Commissioners for fire protection services performed by the Town; and

C. Execute and deliver to Lender all other documents necessary or convenient to consummate the loan approved herein; and

D. Authorize in writing the single principal advance anticipated by the promissory note at such time as the funds are necessary to purchase the fire truck.

WHEREAS, the Town Council of Bronson, Florida on September 23, 2008, held a public hearing as required by Florida Statute 200.065; and



NOW THEREFORE BE IT RESOLVED by the Town Council of Bronson, Florida, that:


1. The Fiscal Year 2008-2009 Final Budget be adopted.

FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM
TAXES FOR FISCAL YEAR 2008-2009; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the Town Council of the Town of Bronson, Florida, on September 23, 2008, adopted Fiscal Year 2008-2009 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Town Council of the Town of Bronson, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Bronson, Florida, Levy County Florida, has been certified by the County Property Appraiser to the Town of Bronson as \$38,652,775.00.


NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Bronson, Florida, that:


1. The Fiscal year 2008-2009 operating millage rate for Town wide is 3.2000 mills, which is less than the rolled back rate of 3.4036 mills by 5.98%.
2. This resolution shall take effect immediately upon its passage and adoption by the Town Council of the Town of Bronson, Florida.
